## GREAT AMERICAN BEER FESTIVAL SWEEPSTAKES PRESENTED BY CYMBA OFFICIAL RULES THE CYMBA BOTTLE OPENER COMPANY

- 1. **PROGRAM DESCRIPTION:** The Great American Beer Festival Sweepstakes (the "Sweepstakes"), sponsored by The Cymba Bottle Opener Company ("Sponsor") provides exhibitors of the 2018 Great American Beer Festival an opportunity to win a prize package, subject to the terms of these Official Rules.

The Sweepstakes are subject to federal, state, and local laws and regulations and are void where prohibited by law.
- 3. **AGREEMENT TO OFFICIAL RULES:** Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sweepstakes Parties and judges, which are final and binding. - b. The Cymba Bottle Opener Company Sweepstakes begins on the Cymba website on July 20, 2018 at 12:00pm Eastern Standard Time ("EST") and ends on July 27, 2018 at 11:59pm EST.
- c. There is only one Entry per person per Submission Period. Duplicate Entries will be void. Entries submitted after the close of the Submission Period will not be eligible to win. Entry locations are not restricted to work or living locations. If Entrant uses fraudulent methods or images or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Sponsor. By entering the Sweepstakes, entrants are also agreeing to the <a href="mailto:cymba.com">cymba.com</a> Terms of Use and these Official Rules. Notwithstanding anything to the contrary in the Privacy Policy, entrants authorize the Sweepstakes Parties to

use any personal information provided to Sponsor solely in connection with the Sweepstakes, including without limitation for prize fulfillment or to enforce these Official Rules. The Cymba Bottle Opener Company is not responsible for entries not received due to difficulty accessing the Internet or Entries that are lost, late, incomplete, misdirected or altered for any reason, including hardware, software, browser or network failure, malfunction, congestion, or incompatibility.

- 5. **DRAWING/ODDS:** On or about July 30, 2018 a potential prize winner will be selected in a random drawing from all eligible entries received by the Sponsor Representative. Odds of winning depend on the number of eligible entries received for the Sweepstakes. By entering the Sweepstakes, Entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of the Sponsor and Sweepstakes Entities, which will be final and binding in all matters relating to the Sweepstakes.
- 6. PRIZE: One Prize Package of a \$500 credit for use to design and produce and ship bottle openers. The approximate retail value ("ARV") of the Prize Package is \$500.00. The prize winner will be notified by email and may be required, at Sponsor's sole discretion, to complete, sign and return an Affidavit of Eligibility, Liability Release, and, where lawful, a Publicity Release which will include, among other things, (a) representations regarding entrant's eligibility to participate in the Sweepstakes and the Entry's compliance with the requirements of these Official Rules, (b) a release of the Released Parties (as defined below) from any and all liability, loss, claims, demands, and causes of action for personal injury and/or damage, theft, loss, or any other harm suffered in connection with this Sweepstakes and for any claim based on publicity rights, defamation, invasion or privacy, copyright infringement, trademark infringement or any other personal or property rights of any party or any other intellectual property related cause of action and, or the use/misuse or acceptance of any Prize to be eligible for the Prize, and (c) permission for Cymba to use your name, likeness, image and other attributes for promotional purposes as described in Section 11, to the extent permitted by law.
- 7. ADDITIONAL PRIZE DETAILS: Any prize details not specified above will be determined by the Sponsor in its sole discretion. Prize is to be delivered by Cymba (exact method to be determined) within 30 days of winner submitting logo or artwork to Sponsor. Prizes are not transferable or refundable and must be accepted as awarded. No other substitutions may be made, except by the Sponsor, who reserves the right to substitute a prize (or component thereof) with another prize (or component thereof) of equal or greater value if the prize is not available for any reason as determined by the Sponsor in its sole discretion. Prize cannot be used towards prior purchases or current orders with The Cymba Bottle Opener Company. Winners are solely responsible for all applicable federal, state, and local taxes and for any expenses, costs or fees associated with acceptance and/or use of prizes not specified herein as being included. Selection as a winner neither obligates Sponsor nor guarantees that Sponsor will televise, broadcast, post online, or in any other manner use said winning Entry, in whole or in part, or any excerpt or portion thereof, as submitted or as modified, edited, produced or re-filmed by Sponsor. Further, Sponsor reserve the right not to award any prizes, or to award

- fewer than the stated number of Prizes, if in their sole and absolute discretion they do not receive a sufficient number of eligible or qualified Entries for the Sweepstakes. Limit one (1) prize per Entry and per household/address. Winners are not eligible to win another Sweepstakes from Sponsor for 6 months after win.
- 8. **GENERAL CONDITIONS:** In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, the Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules; (b) award prizes according to the Judging Criteria from among the eligible Entries received up to the time of the impairment; or (c) to proceed in such a manner as may be deemed fair and equitable by Sponsor in its sole discretion. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

- 10. **INDEMNITY:** You agree to indemnify and hold the Released Party harmless from any and all claims, damages, expenses, costs (including reasonable attorneys' fees) and liabilities (including settlements), brought or asserted by any third party against any of

- the Released Party due to or arising out of your Entry, or your conduct in creating a Entry or otherwise in connection with this Sweepstakes, including but not limited to: claims for trademark infringement; copyright infringement; violation of an individual's right of publicity or right of privacy; or defamation.
- 11. **PUBLICITY:** By submitting an Entry, you grant to Sponsor and its affiliated companies the right, except where prohibited by law, to use your name and entry for advertising and promotional purposes in promoting or publicizing Sponsor, its affiliated companies, and the products or services of each, in any and all media without limitation as to time or territory, without compensation unless required by law. You shall have no right of approval, no claim to compensation, and no claim (including, without limitation, claims based on invasion of privacy, defamation, or right of publicity) arising out of any use, blurring, alteration, or use in composite form of your name or entry.
- 12. **PRIVACY:** Information submitted in connection with the Sweepstakes will be treated in accordance with these Official Rules. By entering this Sweepstakes, you agree that the Sweepstakes Parties may share your personal information with the Sweepstakes Parties for the purpose of winner verification and prize fulfillment in the event that you are chosen as a potential winner.
